Exhibit fees due in full by September 15, 2022

Booth fees are due in full by September 15, 2022. You can log in to the <u>exhibitor portal</u> to pay remaining balances via credit card.

September 15 is also the deadline to cancel your exhibit and receive a partial refund.

Enter Company Description and Categories Online

<u>Log in to the Exhibitor Portal</u> (your password was emailed) to enter your company, product, or service description as well as applicable company or product categories.

After logging in, click on the Exhibitors menu at the top left, select Booth Information from the drop down menu. Complete contact information, description, and check applicable categories. Your mobile app profile is limited to 500 characters and the online profile limit is 1000.

Help attendees learn more about your company in advance. Online profile (description) and categories are now available on the Exhibitor Listing.

Profile and categories will also be uploaded to the mobile app available to attendees starting September 13.

Exhibitor Registration and Housing Sent 48-Hours After Booth Reserved

Martiz is the official Nexus 2022 registration and housing vendor, and they will send a personalized email to the primary exhibit contact with registration and housing information no more than 48-hours after the booth is reserved.

The email is from: email_confirm@confmail.experiant-inc.com and it includes a link with login and password to the Exhibitor Registration Portal. Although the portal is different from where you reserved the exhibit, your password is the same.

IMPORTANT: This is a reminder that the deadline to add names to your reserved room block at the Gaylord National Harbor is **September 1, 2022**. Any rooms needed after September 2, 2021 will be based on availability. Prior to this date you must provide unique guest names (no duplicate names allowed), individual arrival/departure dates and a form of guarantee (credit card). Note that all attendees must be registered for AMCP Nexus 2022 in order to confirm a room in your housing block.
